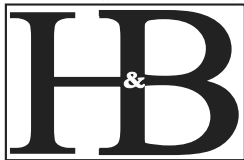

ANATOMICAL DONATIONS WILL BE MORE ASSURED AFTER JULY 1, 2009

"One of the greatest things I could ever wish to accomplish as a State Legislator is to pass a law that's guaranteed to save lives," said Representative Elaine Schwartz, D-Hollywood. On July 1, 2009 her wish was signed into law by Governor Charlie Crist.

Schwartz's Uniform Anatomical Gifts law will expedite the process by which anatomical gifts are given and received. "The law updates some antiquated language in Florida's existing Anatomical Gift Act and, at the same time, brings it in line with enhanced laws from other states. It will make it easier to make anatomical gifts locally and across state lines. There is nothing more fundamental to saving lives than a speedy and efficient donor process," Schwartz said.

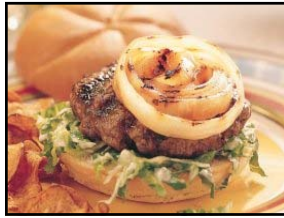

**Grilled Onion
 Caesar Burgers**



- 1 lb lean (80%) ground beef
- 2 tbsp chopped fresh parsley
- 1/2 cup Caesar dressing
- 1/2 tsp peppered seasoned salt
- 1 small sweet onion, cut into 1/4- to 1/2-inch slices
- 1 1/2 cup shredded romaine lettuce
- 2 tbsp freshly shredded Parmesan cheese
- 4 burger buns, split

1. Heat gas or charcoal grill. In medium bowl, mix beef, parsley, 2 tbsp of the dressing and the peppered seasoned salt. Shape mixture into 4 patties, about 1/2 inch thick

2. Place patties on grill over medium heat. Cover grill; cook 12 to 15 minutes, turning once, until meat thermometer inserted in center of patties reads 160°F. Add onion slices to grill for last 8 to 10 minutes of cooking, brushing with 2 tbsp of the dressing and turning once, until crisp-tender.

3. In small bowl, toss lettuce, remaining 1/4 cup dressing and the cheese. Layer lettuce mixture, burger and onion in each bun. Serve hot off the grill!
