Orange-Cream Cheese Brownies

The perfect brownies for any Halloween party!




- 1 package Betty Crocker® Supreme dark chocolate brownie mix
- 2 tablespoons frozen (thawed) orange juice concentrate
- Yellow and Red food color
- 4 ounces soft cream cheese
- 3 cups powdered sugar
- 1/4 cup water
- 1/2 cup vegetable oil
- 2 eggs
- 1/2 cup semisweet chocolate chips
- 1 tablespoon shortening



1. Heat oven to 350°F. Grease bottom of 13x9-inch rectangular pan.
2. Stir brownie mix, chocolate syrup, water, oil and 2 eggs in medium bowl, using spoon, until well blended. Spread in pan.
3. Bake 27 to 29 minutes or until toothpick inserted 2 inches from side of pan comes out clean or almost clean. Cool completely.
4. Stir cream cheese, powdered sugar, orange juice, 4 drops yellow & 2 drops red food color until smooth and spread over brownies.
5. Place chocolate chips and shortening in small microwavable bowl. Microwave uncovered 2 minutes or until mixture can be stirred smooth. Drizzle over brownies. Refrigerate about 30 minutes or until cream cheese and chocolate are set.
