Estate Planning for Your Business

When you own and operate a business, your Buy-Sell Agreement is probably the last thing on your mind. It's something your business attorney drafted years ago and most likely you have not thought about it since. Or, maybe you don't have one at all! Just like your personal estate planning, having an estate plan for your business is very important. Without a buy-sell agreement, a closely held or family business faces the possibility of financial and tax problems on an owner's death, disability, divorce, bankruptcy, sale or retirement. The benefits of having a buy-sell agreement in place far outweigh the cost of creating and maintaining the agreement. A buy-sell agreement can ward off infighting by family members, co-owners and spouses. The buy-sell agreement can also help keep the business afloat in the event of one of these major life events.

A buy-sell agreement is good for any business entity, including corporations, partnerships, LLCs and even sole proprietorships. Let's say you and your business partner, David, run an ice cream shop as 50/50 partners. Your partnership is based on a mere handshake. David dies. Do you still have a business? Is David's spouse or child your new partner? Do you have the right or the obligation to buy them out? If so, for how much and under what terms? What happens if you die instead of David? The most basic business needs a buy-sell agreement. It's the business owners' opportunity to set forth in black and white the expectations of the owners when a life crisis occurs.

One type of buy-sell agreement is a cross-purchase agreement. With a cross-purchase agreement if you or David die, become disabled, etc. one owner can buy out the other owner's share. A different type of buy-sell is a redemption agreement. With this style of agreement, the business ...
